FLORIDA RULE OF CRIMINAL PROCEDURE 3.692

THIS CAUSE having come on to be heard before me this date upon a petition to expunge certain

ORDERED AND ADJUDGED that the Clerk of this court shall forward a certified copy of this order to the \_\_ State Attorney, \_\_Special Prosecutor, \_\_ Statewide Prosecutor, \_\_\_\_\_(arresting agency), and the Sheriff of Pinellas County, who will comply with the procedures set forth in section 943.0585, Florida Statutes, and appropriate regulations of the Department of Law Enforcement, and who will further forward a copy of this order to any agency that their records reflect has received the instant criminal history record information; and it is further

ORDERED AND ADJUDGED that \_\_\_\_\_ (arresting agency) shall expunge all information concerning indicia of arrest or criminal history record information regarding the arrest or alleged criminal activity to which this petition pertains in accordance with the procedures set forth in section 943.0585, Florida Statutes, and Florida Rule of Criminal Procedure 3.692. All costs of certified copies involved herein are to be borne by the Petitioner.
