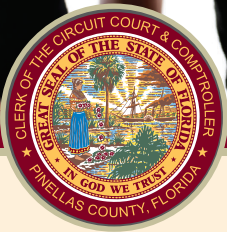

# SELF HELP CENTERS

## Services available:

- Attorney consultations for a minimum of \$15. (*Family Law, Small Claims and Landlord/Tenant matters ONLY.*) Attorney appointments may be scheduled for a minimum of 15 minutes to a maximum of one hour in 15-minute increments. Attorney consultation fees must be paid when the appointment time is scheduled. Payments may be made by credit card, cash, check or money order. Refunds will not be issued for cancelled or missed appointments.
- Form and packet purchases for civil court actions.
- Notarization and copies of documents.
