In order to be eligible to register for the 2018 wedding event, application for a marriage license must be made between December 16, 2017 and February 9, 2018. The ceremony will take place at 2:00 p.m. in the Wedding Garden of the Florida Botanical Gardens located at 12520 Ulmerton Road, Largo, FL 33774. Couples will receive a special Commemorative Marriage Certificate, which will be mailed within one week from the date of the ceremony with the official Certificate of Marriage. All couples should arrive at the Botanical Gardens by 1:00 p.m. on the day of the event with their marriage license and identification.
